Dependent Your application was selected for review in a process called "verification." **WHAT YOU MUST DO BEFORE FINANCIAL AID CAN BE AWARDED TO YOU**

1. **If you and your parents used the IRS Tax Retrieval process when completing your FAFSA and did not make any changes to that information, a 2017 tax transcript is not necessary.**
2. If you and your parents did not use the IRS Tax Retrieval process or you made changes after the IRS Retrieval was used, contact the IRS at www.irs.gov or call 1-800-829-1040 to obtain a 2017 transcript. **YOU MUST REQUEST A TAX RETURN TRANSCRIPT FROM THE IRS.**
3. **Complete all sections (do not leave anything blank) and sign the worksheet.** You and your parents must sign the worksheet.
4. Submit all required documents to the Office of Financial Aid.
5. If you or your parents did not file or are not required to file an IRS 1040, you and your parents must affirm that you are not required to file an IRS 1040 and include a copy of 2017 W-2 Forms from all employers. (See section "C" and "D")
